Growing Pains: Reimaging Culpability for Simple Possession. Young adults, ages of 18 to 20, are in a uniquely precarious position in our criminal justice system when it comes to criminal culpability for minor possession of marijuana. Generally, they are categorized as "minors," under 21, which includes juveniles who are under 18 years old. Young adults are too young to be treated as adults, yet too old to be protected as juveniles. Consequently, young adults are treated in a disparate manner from both adults and juveniles, which results in adverse direct and collateral consequences. I coin this phenomenon as the "status crime conundrum." This inequity demands that we reimaging how young adults are treated in our criminal justice system.

This Article examines how the status crime conundrum operates relative to criminal culpability for the simple, non-violent possession of recreational marijuana. It seeks to reimage status crimes as applied to young adults through the lens of criminal culpability for simple, non-violent possession of recreational marijuana. Consequently, this Article posits that equal justice demands that the status crimes of the simple, non-violent possession of recreational marijuana should be decriminalized for minors who are 18 and 20, treating these as civil offenses subject to only warnings or small civil fines. Further, it argues that such a reform in the criminal justice system would serve the best interest of young adults by promoting emotional and rehabilitation support strategies and discarding the current system of direct and collateral damage that results from a criminal record.
