 - i. Barristers Ball

- Cost
 - Initial contract with Aquarium (venue & food/beverage): \$20,854
 (a) +50 tickets: no invoice yet, expected? < \$2,500
 - o DJ: \$805
 - Photographer: \$250
- Recuperation through ticket sales & fundraising
 - \circ 246 tickets @ \$50 = \$12,300
 - (a) -2: prizes for halloween costume contest
 - (b) -2: exchanged for student creating physical tickets for free
 - \circ 50 tickets @ \$60 = \$1,200
 - T-shirts: \$3 (estimated profit) x 174 (based on last year) = \$522
 - Candy grams: 147@\$1, \$40 (cost of candy) = \$107 profit
 - Tumblers: \$10 (profit) x $34 = $340 \rightarrow 13$ left, possible to + \$130
- \$24,409 (possible total) \$14,469 (recouped) = \$9,940 (possible net cost)
- Will create more extensive report when things are all finalized
- ii. Approximately \$20,000 left in the account as of today
 - Candy gram, ticket, and tshirt money already deposited
 - \$340, possibly \$470, being deposited before the end of the semester
 - Not much more will come out of the account to pay for Barristers
